

# SECRETARY-TREASURER'S REPORT (revised)

As of November, 1998, \$5266.06 was deposited in the Association account with the Membership Secretary-Treasurer. This figure reflects the closing of the account in San Bernardino, and the opening at Northridge under the capable direction of the new Secretary-Treasurer, Barnabas Hughes. This figure includes the cost of the the joint issue (in your hands, deo gratia) Fall/Spring Chronica, which has run about \$3,000. This is less than the two-issue Chronica, at \$4,000, which remains the largest budgetary item, and this expense may continue to rise, for which, see below on the increase in dues.

Once again, as the Council has for the past six years, California State University at San Bernardino was recognized for its generosity, in supporting her activities as Secretary-Treasurer. In further business,

In the official roster, there are 432 members in the Association, down from last year's 491, as the Association continues to delete former members who have not paid their dues in three years, and those who did not respond were taken off the list. Of this number, 362 are from the United States, 45 from Canada, 20 from Japan, one each from the United Kingdom, Hong Kong, New Zealand, Australia, and Denmark.

By November 3, 1998, 113 members had paid their dues, and perhaps those reading these minutes will remind themselves if they have.

The Secretary reported that the Association's effort to achieve official tax-exempt status with the Internal Revenue Service has finally succeeded, and all of our deductions are officially legal.

#### **CHRONICA**

In another cyclical ceremony, the Editor-Pro-Tempore of *Chronica* once again apologized profusely for the late publications (*chronically* late, he has been later quoted as saying). Thankfully, his offer to surrender his position was gratefully taken up by the new Editor, Phyllis Brown of Santa Clara, for which, see below.

The deadline for contributions to the Spring Chronica is March 1.

#### OFFICERS AND ADVISORY COUNCIL MEMBERSHIP

At the end of her two-year term, President van Deusen gracefully surrendered her office to the incoming President, Glenn Olsen. Later, Dhira B. Mahoney, English, Arizona State University, accepted the offer to the Vice-President's office. In the meeting, and in the business meeting two days later, President van Deusen was warmly thanked for her excellent service.

For the first time in many years, there was also a change in the other officers: a new Secretary-Treasurer was appointed: Barnabas Hughes, O.F.M., Education Department, California State University, Northridge (hcedu037@email.csun.edu); and a new Editor of *Chronica*: Phyllis Brown, English, University of Santa Clara (pbrown@scuacc.scu.edu). The Association warmly thanks officers Cheryl Riggs and Kevin Roddy for their combined twenty-three years of service.

The four outgoing members of the nominating committee proposed the following slate for the four new council positions, which would extend to 2001.
